

## Miss Pre-Teen Georgia International Rules and Regulations

Pre-Teen Georgia International Contestant must be a minimum of 8 years of age and no older than 12 years of age by April, 15 2007.

Contestant must be of good health & moral character.

Contestant vying for a state title must be a U.S. citizen and a six month resident in the state of her entry, or attend school full time in that state.

A contestant may be selected to participate as a delegate "at-large" if there is no competition in her area, state / region or country. Regional contestants cannot have participated at nationals in the prior year.

Contestant will be subject to a registration or sponsor fee of \$300.

Any contestant and/or family member or guest showing less than sportsman like behavior will lead to the disqualification of the contestant. No refund will be given under these circumstances.

All decisions of judges at the Local, State / international and National level are final and irrevocable.

Contestant agrees to abide by all rules and regulations of the Regional, State and International competitions.

If under age 18, the contestant must have a parent or legal guardian to serve as a chaperone during her attendance at the state and national pageant. A parent or legal guardian must be responsible for any contestant under age 18, while attending the state pageant including, but not limited to, stays at the hosting hotel, any tours, appearances, or sight-seeing events which may be scheduled for the contestants over the weekend competition. The Miss Teen Georgia / Miss Georgia International Pageant, state directors, or staff members shall not be held responsible for the guardianship of contestants.

Contestant will permit the Georgia International Pageant and their licensees the right to use contestant's photograph for publicity purposes in connection with all International competitions.

Contestant will permit Georgia International Pageants and their licensees to televise live or by use of film or videotape any portion or all of the competition.

Contestant understands that Georgia International Pageant Director reserves the right to change the dates & location of the Georgia International pageant.

Contestant understands that if selected a winner of her competition, that for one year her professional affairs, as said winner, will be under the sole management of the Georgia International Pageant Board and /or their licensees and that she will not give any written or oral endorsements commercially, without the expressed permission of said same. Contestant further acknowledges that all rights for any appearances, endorsements, speaking engagements, acting roles, etc. resulting from winning or being a contestant in any regional, state or international competition affiliated with Georgia International Pageants shall belong exclusively to same.

The Contestant agrees to abide by all rules and regulations set forth by the state and national competitions or forfeit the title.

If the contestant relinquishes her title for any reason, her title, all prizes, must be returned in full, and in the condition they were received.

These rules and regulations are subject to modification, as needed, without prior notice. Pageant reserves the right to make said modifications at its sole discretion.
